The publication also includes various factors and correction tables, a glossary, AWPA's Technical Committee Regulations, and pertinent guidance documents. Online Subscriptions to AWPA Standards

New for 2022, AWPA is offering single and multi-user subscriptions to the AWPA Standards which may be viewed via internet web browser. There are two subscription options: a 2022 Standards Subscription, and a 12-Month Annual Subscription. 2022 Standards Subscription: This option allows access to the AWPA standards which are published in the 2022 AWPA Book of Standards for a period of three years. The standards available in this option will not change during the three-year period. 12-Month Annual Subscription: This option allows access to all then-current AWPA standards collection for a period of one year. When any new or revised standards are published within the subscription period, the user(s) will have access to those standards while the subscription is still active. For example, if the 2023 edition of the AWPA Book of Standards is published during the subscription period, this option will also allow access to the new and revised as published in that edition. However, online access to all standards will end upon the expiration of the annual subscription, so renewal each year is required for continued access to the AWPA standards.
